Following the 23 January Special Cabinet Meeting to consider the recommendations to revoke the determination of contaminated land, I am writing to update you on progress.

Cabinet approved the recommendation to revoke the Notice of Identification which has enabled the Council to progress with preparing the necessary legal documentation to revoke the 2012 determination.

The Notice of Revocation of Identification of Contaminated Land ("the Notice of Revocation") and the Record of Revocation of Determination ("the Record") will be placed on the Council's Contaminated Land Register. This means that anyone carrying out searches against land or properties at the addresses listed below will see that the land is no longer categorised as contaminated under Part 2A of the Environmental Protection Act 1990 and the reasons why.

The register will apply to all land and properties at:

- Kemble Close numbers 1-27 (all) WV12 4DQ
- Brookthorpe Drive numbers 1-40 (all) WV12 4TX
- Oakridge Drive numbers 1-25 (odds) WV12 4EN
- Oakridge Drive numbers 27-47 (odds) WV12 4DJ
- Oakridge Drive numbers 22-38 (evens) WV12 4DL

In response to the Cabinet decision and as discussed at the residents' meeting, I enclose the following legal documents by way of service upon you:

(1) A copy of the Notice of Revocation of Identification. This document has two schedules: Schedule 1 lists the properties to which it applies, and Schedule 2 comprises a location plan.

(2) A copy of the Record of Revocation of Determination. This document also has two schedules. The first shows a plan of the area. The second schedule identifies the reasons why the Council has decided to revoke the designation. Schedule 2 is important as it demonstrates what the Council has done, it summarises the technical evidence, sets out the statutory guidance and provides the reasons for the Council's decision.

You are advised to keep a copy of the enclosed documents for future reference. They will also remain available on the Council's register indefinitely and can be found using the following links:
