

## NOTICE OF DETERMINATION OF AN APPLICATION TO SURRENDER A WASTE MANAGEMENT LICENCE

To: Biffa Waste Services Ltd Coronation Road Cressex High Wycombe Buckinghamshire HP123TZ

In pursuance of your application dated 14 May 2007 to surrender Waste Management Licence reference number SL 140 (EAWML41312) dated 11 October 1983 issued by West Midlands County Council for land at Unit 4, 17B Middlemore Lane West, Aldridge, West Midlands, WS9 8DS,
