# Introductory note

This introductory note does not form a part of the licence

This licence permits the holder to operate a Household, Commercial and Industrial Waste Transfer Station with waste treatment at the specified location. The inputs are limited to non-hazardous and inert wastes and do not include hazardous wastes such as asbestos. Wastes of similar types will be transferred into larger containers and sent to other waste facilities for further treatment or recovery. Wastes can be bulked up for recovery elsewhere and also can be treated by sorting, separation, screening, baling, shredding, crushing and compaction of waste. This licence does not permit the burning of any wastes, either in the open, inside buildings or in any form of incinerator.

This is a bespoke licence.

This licence does not allow any emission into surface waters or groundwater. However:

- Liquids may be discharged into a sewer subject to a consent issued by the sewerage undertaker.
- Liquids may be tankered off-site for disposal or recovery.

Clean surface water from roofs, or from areas of the site that are not being used in connection with the storage and treatment of waste, may be discharged directly to surface waters, or to groundwater by percolation through the soil via a soakaway.

#### Operational requirements specified in regulations

Some aspects of the activity are not controlled by the conditions of this licence, because the controls are specified in the Waste Management Licensing (WML) Regulations<sup>1</sup>, or other legislation. These include:

- Regulation 4 of the WML Regulations describes the qualifications required by a technically competent person at a waste management facility.
- Section 33 (1)(c) of the Environmental Protection Act 1990 prohibits the treating, keeping or disposal
  of controlled waste in a manner which causes or is likely to cause pollution of the environment or
  harm to human health.
- Section 85 of the Water Resources Act 1991 under which it is an offence to cause or knowingly
  permit polluting matter to enter controlled waters (which include both surface and ground waters)
  unless the discharge is specifically allowed in a permit.
- The Oil Storage Regulations<sup>2</sup> require oil storage tanks to be bunded.

#### **Public Registers**

The public registers in Environment Agency offices contain information relating to licences including the application and monitoring results. Certain information may be withheld from public registers where it is commercially confidential or contrary to national security. Some information is also available on the Environment Agency's website (see below).

#### Appeals against the conditions in the licence

The licence holder may appeal to the Secretary of State against any of the conditions imposed by this licence, within 6 months of the date of issue.

#### Licence modifications, transfers and surrender

The Environment Agency may modify the conditions of this licence in the future. If the licence holder wishes to modify the conditions, transfer the licence to another person or surrender the licence then he must submit an application to the Environment Agency.

#### Other permits at this location

There may be other environmental permits at this location, issued to different operators/licence holders or to the same operator/licence holder for different activities. There may also be permits issued by another regulator such as the local authority. For information on any other Environment Agency-issued permits please contact the Environment Agency (see below).

This waste management licence does not remove the licence holder or operator from their obligations under any other legislation.

#### Conditions

#### 1 - MANAGEMENT

#### 1.1 General management

- 1.1.1 The activities shall be managed and operated:
  - (a) in accordance with a management system, which identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents and nonconformances and those drawn to the attention of the licence holder as a result of complaints; and
  - (b) by sufficient persons who are competent in respect of the responsibilities to be undertaken by them in connection with the operation of the activities.
- 1.1.2 Records demonstrating compliance with condition 1.1.1 shall be maintained.
- 1.1.3 Any persons having duties that are or may be affected by the matters set out in this licence shall have convenient access to a copy of it kept at or near the place where those duties are carried out.

#### 1.2 Accident management plan

- 1.2.1 The licence holder shall:
  - (a) maintain and implement an accident management plan;
  - (b) review and record at least every 4 years or as soon as practicable after an accident, (whichever is the earlier) whether changes to the plan should be made;
  - (c) make any appropriate changes to the plan identified by a review.

## 1.3 Site security

1.3.1 Site security measures shalf prevent unauthorised access to the site, as far as practicable.

## 2 - OPERATIONS

#### 2.1 Licensed activities

2.1.1 The licence holder is authorised to carry out the activities specified in schedule 2, table 2.1 ("the activities").

### 2.2 Waste acceptance

- 2.2.1 Waste shall only be accepted if:
  - (a) it is of a type and quantity listed in schedule 2, table 2.2; and
  - (b) it conforms to the description in the documentation supplied by the producer and holder.

2.2.2 Records shall be maintained of all waste accepted onto the site.

#### 3 – EMISSIONS AND MONITORING

#### 3.1 Emissions to air, water or land

3.1.1 There shall be no point source emissions to air, water or land.

#### 3.2 Transfers off-site

3.2.1 Records of all the wastes sent off site from the activities, for either disposal or recovery shall be maintained.

#### 3.3 Fugitive emissions of substances

- 3.3.1 Fugitive emissions of substances (excluding odour and noise) shall not cause pollution. The licence holder shall not be taken to have breached this condition if appropriate measures have been taken to prevent or where that is not practicable, to minimise, those emissions.
- 3.3.2 Litter or mud arising from the activities shall not cause pollution. The licence holder shall not be taken to have breached this condition if appropriate measures have been taken to prevent or where that is not practicable, to minimise, the litter and mud.
- 3.3.3 Litter and mud arising from the activities shall be cleared from affected areas outside the site as soon as practicable.
- 3.3.4 All liquid wastes, whose emission to water or land could cause pollution, shall be provided with secondary containment, unless the licence holder has used other appropriate measures to prevent or where that is not practicable, to minimise, leakage and spillage from the primary container.

#### 3.4 Odour

3.4.1 Emissions from the activities shall be free from odour at levels likely to cause annoyance outside the site, as perceived by an authorised officer of the Agency, unless the licence holder has used appropriate measures to prevent or where that is not practicable, to minimise, the odour.

#### 3.5 Noise

3.5.1 Emissions from the activities shall be free from noise at levels likely to cause annoyance outside the site, as perceived by an authorised officer of the Agency, unless the licence holder has used appropriate measures to prevent or where that is not practicable, to minimise, the noise.

#### 3.6 Pests

3.6.1 Scavenging animals, scavenging birds and other pests shall not cause pollution. The licence holder shall not be taken to have breached this condition if appropriate measures have been taken to prevent or where that is not practicable, to minimise, such pollution.

#### 3.7 Monitoring

3.7.1 This licence does not require any monitoring of the activities, emissions or the environment.

#### 4 - INFORMATION

#### 4.1 Records

- 4.1.1 All records required to be made by this licence shall:
  - (a) be legible;
  - (b) be made as soon as reasonably practicable;
  - (c) if amended, be amended in such a way that the original and any subsequent amendments remain legible or are capable of retrieval; and
  - (d) be retained, unless otherwise agreed by the Agency, for at least 6 years from the date when the records were made, or in the case of the following records until licence surrender:
    - (i) off-site environmental and health effects; and
    - (ii) the condition of land and groundwater.
- 4.1.2 Any records required to be made by this licence shall be supplied to the Agency within 14 days, where the records have been requested in writing by the Agency.

#### 4.2 Reporting

- 4.2.1 All reports and notifications required by the licence shall be sent to the Agency using the contact details supplied in writing by the Agency
- 4.2.2 A summary report of the waste types and quantities accepted and removed from the site shall be made for each quarter. It shall be submitted to the Agency within one month of the end of the quarter and shall be in the format required by the Agency.

#### 4.3 Notifications


- 4.3.1 The Agency shall be notified without delay following the detection of:
  - (a) any malfunction, breakdown or failure of equipment or techniques, accident or fugitive emission which has caused, is causing or may cause significant pollution;
  - (b) the breach of a limit specified in this licence; and
  - (c) any significant adverse environmental and health effects.
- 4.3.2 Written confirmation of actual or potential pollution incidents and breaches of emission limits shall be submitted within 24 hours.
- 4.3.3 Prior written notification shall be given to the Agency of the following events and in the specified timescales:
  - (a) as soon as practicable prior to the permanent cessation of any of the activities;
  - (b) cessation of operation of all or part of the activities for a period likely to exceed 3 months;
  - (c) resumption of the operation of all or part of the activities after a cessation notified under (b) above

- 4.3.4 Where the Agency has requested in writing that it shall be notified when the licence holder is to undertake monitoring and/or spot sampling, the licence holder shall inform the Agency when the relevant monitoring is to take place. The licence holder shall provide this information to the Agency at least 14 days before the date the monitoring is to be undertaken.
- 4.3.5 The Agency shall be notified within 7 days of any changes in technically competent management and the name of any incoming person together with evidence that such person has the required technical competence.
- 4.3.6 The Agency shall be notified within 14 days of the licence holder and/or any relevant person being convicted of a relevant offence, (unless such information has already been notified to the Agency), with details of the nature of the offence, the place and date of conviction, and the sentence imposed.
- 4.3.7 The Agency shall be notified within 14 days of the licence holder and/or any relevant person lodging an appeal against a conviction for any relevant offence and of the outcome when the appeal is decided.
- 4.3.8 The Agency shall be notified within 14 days of the occurrence of the following matters except where such disclosure is prohibited by Stock Exchange rules:
  - a) Where the licence holder is a registered company:
  - any change in the licence holder's trading name, registered name or registered office address
  - any change to particulars of the licence holder's ultimate holding company (including details
    of an ultimate holding company where a licence holder has become a subsidiary);
  - any steps taken with a view to the licence holder going into administration, entering into a company voluntary arrangement or being wound up; and
  - if the licence holder is not the operator; any change in the operators trading name; address; registered name or registered office address.
  - b) Where the licence holder is a corporate body other than a registered company:
  - any change in the licence holder's name or address;
  - any steps taken with a view to the dissolution of the licence holder; and
  - if the licence holder is not the operator: any change in the operators trading name; address; registered name or registered office address.
  - c) In any other case:
  - the death of any of the named licence holders (where the licence holder consists of more than one named individual);
  - any steps taken with a view to the licence holder, or any one of them, going into bankruptcy, entering into a composition or arrangement with creditors, or, in the case them being in a partnership, dissolving the partnership; and
  - if the licence holder is not the operator: any change in the operators trading name; address; registered name or registered office address.
- 4.3.9 The Agency shall be notified at least 7 days in advance of the commencement of any of the activities.

#### 4.4 Interpretation

4.4.1 In this licence the expressions listed in schedule 3 shall have the meaning given in that schedule.

# Schedule 3 – Interpretation

"accident" means an accident that may result in pollution.

"notify/notified without delay" means that a telephone call cambe used, whereas all other reports and notifications must be supplied in writing, either electronically or on paper.

"pollution" includes pollution of the environment, harm to human health and serious detriment to the amenities of the locality, resulting from the licensed activities.

"quarter" means a calendar year quarter commencing on 1 January, 1 April, 1 July or 1 October.

"relevant person" and "relevant offence" shall have the meaning given to them in the Environmental Protection Act 1990

"sealed drainage system" in relation to an impermeable surface, means a drainage system with impermeable components which does not leak and which will ensure that:

- (a) no liquid will run off the surface otherwise than via the system;
- (b) except where they may lawfully be discharged all liquids entering the system are collected in a sealed sump.

"sewer" means sewer within the meaning of section 219(1) of the Water Industry Act 1991.

"technically competent management" and "technical competence" shall be as prescribed under Section 74 of the Environmental Protection Act 1990.

"waste code" means the code specified in The List of Wastes (England) Regulations 2005 (SI 2005 No. 895) as amended, or The List of Wastes (Wales) Regulations 2005 (SI 2005 No.1820) (W.148) as amended. Codes marked with an \* are hazardous waste, as defined in those regulations. Licence conditions apply to those wastes listed with a six-digit code.

"Waste Management Licensing Regulations", means The Waste Management Licensing Regulations 1994 (SI1994 No. 1056) (as amended).



#### Introduction

This Working Plan has been prepared in accordance with the Waste Management Licensing Regulations 1994 and sets out the considerations and operational details that are relevant to the operation of a materials recycling facility at Fryers Road, Bloxwich, W Midlands. WS3 2XJ.

The Working Plan accompanies an application for a Waste Management Licence submitted under the terms of the above Regulations and the Environmental Protection Act 1990.

The application relates to the use of part of the Fryers Road site as a Materials Recycling Facility (MRF) for the receipt and storage and processing of inert waste materials for their reuse as construction materials and other recyclate streams.

The operation comprises the receipt of commercial and industrial (C&I) waste materials together with supplementary sources from selected construction and demolition waste streams. This feedstock will be reprocessed to form recycled aggregates and other construction materials (i.e. soils and fill) together with recyclates for further processing elsewhere (plastics, timber, metals, cardboard and paper). The MRF would receive waste predominantly from within EWC groups 17 (construction and demolition) and 20 (commercial and industrial fractions). No biodegradable or hazardous wastes would be accepted.

This Working Plan sets out the nature of the site, relevant plant and infrastructure works, methods of operation and environmental control.

All of the waste handling, storage and processing operations would be undertaken within specifically appointed areas located within the site as shown on Figure JPE/MRF/03.

# 1. Site Description and Characterisation of Risk Source

# 1.1 Specified site and waste management operations

- 1.1.1 The site is on land within the Fryers Road site as indicated on Figure JPE/MRF/01. Access is gained to the site via the main gates off Fryers Road. Operations to be carried out on the site are:
  - R4 Recycling/reclamation of other inorganic materials
  - R13 Storage of materials intended for operations above (as defined in Annex II B of EC Framework Directive on Waste (91/156/EEC)).

- 1.1.2 The application relates to the use of the site as a Materials Recycling Facility (MRF) for the receipt, storage and processing of commercial and industrial waste materials together with supplementary streams of selected construction and demolition wastes and for their reuse as construction materials or onward supply of other recyclates for further processing.
- 1.1.3 The operation comprises the receipt of these waste materials and their reprocessing (including washing) to form recycled aggregates and other

construction materials (i.e. soils and fill). The MRF would receive waste predominantly within EWC categories 17 and 20.

#### 1.2 Permitted Wastes

1.2.1 The Waste Licence application is for the receipt of inert wastes including commercial and industrial wastes (C&I) and selected construction and demolition (C&D) wastes, free from excessive contaminants.

Waste types to be processed at the site are set out in Table 1.2 below:

1.2.2 Any loads containing excessive levels of contaminants such as organic or biodegradable materials, plasterboard, oils or other liquids and any special wastes (as defined by the Special Waste Regulations) will be rejected and directed to an appropriate landfill site.

- 1.2.3 The site accepts waste streams from public utility and commercial contractors only and is not available for use by the general public.
- 1.2.4 Wastes types will be separately stored particularly those comprising source separated construction and demolition wastes. All wastes will be stored within the buildings provided as indicated on Figure JPE/MRF/03.
- 1.2.5 Non acceptable materials will be diverted to an appropriate alternative site as necessary.

# 1.3 Hours of operation

- 1.3.1 The site will be open to receive wastes from 07.00 to 18.00 Monday to Friday and 07.00 to 13.00 on Saturdays. The site will be closed on Sundays and public holidays. The receipt of waste is also limited to daylight hours or where adequate lighting is available. Waste sorting operations will take place between the hours of 06.00-22.00 Monday Friday and 06.00 14.00 Saturday.
- 1.3.2 Outside of these specified hours, receipt of wastes will be limited to emergency situations only. Such situations may include access to the site to allow off peak highway repairs to dispose of waste arisings. Such "emergency" openings will be limited to six per year and will be notified to the Agency at least 7 days in advance. Any other emergency use such as that resulting from vehicle breakdown will be notified to the Agency immediately thereafter.

# 1.4 Amendments to the Working Plan and Supporting Information

- 1.4.1 Any proposed changes to the Working Plan or the operations within the specified area will be notified to the Agency and accompanied by an assessment of the risk to human health or the environment that such changes may pose.
- 1.4.2 Those changes requiring prior approval by the Agency shall not be implemented until such written approval is received. All other changes requiring pre

notification shall form part of the adopted Working Plan following notification to the Agency.

# 1.5 Staffing and supervision

- 1.5.1 The site is operated under the ultimate control of the Directors of the company but day to day responsibility rests with the Site Manager who will hold the appropriate level of competency.
- 1.5.2 The operation requires 25 full time employees who are supported as necessary by employees elsewhere within the Group. Staffing levels are sufficient to operate the site effectively throughout periods of employee sickness and holidays.
- 1.5.3 All staff are fully conversant with the requirements of the Licence and in particular the nature of acceptable wastes and the drainage control requirements.
- 1.5.4 The site falls within the requirements of Waste Management Paper No 4 and Circular 11/94 and the applicant's Site Manager is in the process of obtaining a formal COTC (4TMNH) under the WAMITAB scheme.

#### 1.6 Relevant Convictions

- 1.6.1 The Licence holder will notify the Agency forthwith of any convictions or appealed convictions under waste management legislation.
- 1.6.2 Written notification will include details of the offence and any mitigating circumstances offered in defence.

# 1.7 Notification of a Change of Operator or Licence Holder

1.7.1 The Licence holder will notify the Agency within one week of any changes to its name, registered office or parent company. It will also provide advance notice of any application for administration or insolvency.

# 1.8 Notification of preparatory works

- 1.8.1 The site is part of a remediated industrial employment site with planning permission for the construction of industrial building and associated infrastructure.
- 1.8.2 These elements of the development of the site as an MRF have commenced including the provision of the buildings, access, weighbridge, surfacing and drainage control.
- 1.8.3 Any additional preparatory works required as a result of this issuing of a formal waste management licence would be notified to the relevant authority.
- 1.8.4 No wastes would be received until a validation report as to the adequacy of any preparatory works had been received from the Environment Agency.
- 1.9 Notification of commencement, cessation and re-commencement of waste handling operations
- 1.9.1 The Agency will be notified in writing one week prior to the commencement of waste handling within the site.
- 1.9.2 In the event of any future cessation and subsequent re-commencement, the relevant authorities would be notified in writing specifying the date of any such cessation or re-commencement.

- 2.1.1 The site has been fully remediated and validated as such by the Environment Agency. As part of the remediation programme, there is a requirement for all engineering works related to further development of the site to maintain the integrity of the low permeability capping layer.
- 2.1.2 The remediation also required the control of future water infiltration through the containment of all surface water and its disposal to sewer.
- 2.1.3 As a consequence the site includes a fully integrated drainage system that takes into account the findings of a Flood Risk Assessment that was undertaken in support of the planning application for industrial units.
- 2.1.4 In addition to this strict control of surface water, all process water associated with the integral washing plant is re-circulated with no external, uncontrolled discharges.
- 2.1.5 Containment within the site is further enhanced through the enclosure of all waste related and waste storage activities.
- 2.1.6 No wastes will be handled within the site until such arrangements have been constructed and approved by the Agency.

### 2.2 Removal of residual wastes from site

2.2.1 The load is inspected prior to offloading for unsuitable wastes and contaminants and will be rejected if these are present in significant quantities.

- 2.2.2 If accepted, the load will be allowed to tip in the waste storage area and a second visual check for buried contaminants and unsuitable wastes is made. Only those wastes listed within Table 1.2 are accepted at the site.
- 2.2.3 If non-conforming wastes are found to be present in any significant quantity, the material is reloaded onto the incoming vehicle and rejected from the site.
- 2.2.4 Details of all rejected loads are recorded in the site diary and recorded tonnages adjusted accordingly.
- 2.2.5 Loads which contain only minor quantities of non-conforming wastes are accepted in the knowledge that these wastes will be removed during the reprocessing and sorting operations. Containers are provided within the site (Figure JPE/MRF/03) for storing non-conforming wastes prior to disposal at an alternative, licensed site.
- 2.2.6 Non-conforming wastes will be removed from the containers provided, within 5 working days.

#### 3 Site Infrastructure

#### 3.1 Provision of site identification board

- 3.1.1 A site information notice as required under the Waste Management Licence is located at the highway entrance to the site (Figure JPE/MRF/02).
- 3.1.2 The notice contains all the required elements including opening hours, the operator's details, telephone number and Licence details as well as phone numbers for the Environment Agency and emergency numbers.

## 3.2 Site Security

- 3.2.1 The site is bounded on all sides by a 2.1m high galvanised palisade fence. Vehicular and pedestrian gates are provided at the entrance off Fryers Road. Outside of normal business hours these access points are locked and secured.
- 3.2.2 The site is also serviced by a rail spur off the main railway line complex owned by Network Rail. Access to this site from this method is also controlled by a locked gateway.
- 3.2.3 The site weighbridge function and operators provide continual supervision of all traffic movements in and out of the recycling facility.
- 3.2.4 All boundary fences and gates are checked on a regular basis for damage or signs of attempted entry. Such occurrences are entered in the site diary and any damage is repaired at the earliest opportunity.

# 4 Site Operations

#### 4.1 Control of mud and debris

- 4.1.1 The access is checked daily for mud and other debris which may present a hazard to the highway. The fully surfaced site is sufficient to ensure that highway cleanliness can be maintained without recourse to specific wheel cleaning equipment.
- 4.1.2 However, high pressure hose equipment is available within the site for use as necessary in extreme conditions.

# 4.2 Potentially polluting leaks and spillages

- 4.2.1 Drains are inspected daily and cleaned at regular intervals to ensure that at no time does any surface water leave the site other than via the drainage control system. No surface water is allowed to contaminate local ditches or waterways.
- 4.2.2 Any incoming loads found to contain quantities of hazardous, difficult or potentially polluting wastes such as bonded asbestos, acid batteries or tyres, are isolated in a secure area and the Environment Agency contacted immediately for advice on handling and onward disposal.
- 4.2.3 Gas oil for use by mobile equipment is stored within the complex in a fully bunded surface tank. The installation is in accordance with recognised pollution prevention guidelines and is bunded with a sealed wall capable of containing 110% of the tank's capacity. Stock levels are checked regularly and recorded.
- 4.2.4 Servicing of plant and equipment is carried out within designated workshop facilities as indicated on Figure JPE/MRF/03. All consumables including oils and filters are contained and disposed of according to industry best practice using an oil recycling contractor.

- 4.2.5 Chemical absorbents are available for use in the event of accidental oil or fuel spillages. All loose oils and greases are stored in a secure container store within the workshops.
- 4.2.6 Equipment is maintained to the highest standards to minimise the potential for unexpected leaks or hose ruptures.

#### 4.3 Fires on site

- 4.3.1 In the unlikely event of a minor fire within the site, fire hoses and extinguishers are available and employees have been trained in their correct use.
- 4.3.2 Extinguishers are fitted within the shovels and excavators. Fire escape doors are fitted throughout the buildings.
- 4.3.3 Assembly points in the event of an emergency are displayed at the weighbridge office.
- 4.3.4 In the event of a major fire, the entire area would be evacuated and the Fire Service called.

# 4.4 Waste acceptance and control systems and procedures

- 4.4.1 All incoming waste vehicles are required to proceed directly to the weighbridge as indicated on Figure JPE/MRF/03, where details of vehicle registration, source of waste and weight is recorded.
- 4.4.2 All loads are inspected prior to off loading to check for non-conforming wastes or contaminants which if found in a quantity which is incompatible with the Waste Management Licence, will cause the entire load to be rejected and removed from site.

- 4.4.3 If such unsuitable materials are found after the load has been tipped, it will be reloaded and removed from site.
- 4.4.4 The nature of the wastes that are accepted under the Licence are such that they will occasionally contain small quantities of wastes for which the site is not licensed. These are removed and stored in the waste containers provided for subsequent removal from site. Such contaminant materials are not kept on site for more than 5 working days.
- 4.4.5 Details of any rejected loads are recorded in the site diary and the tonnage records adjusted accordingly.
- 4.4.6 All staff are well versed in the importance of only accepting wastes for which the site is licensed and the implications of contaminants in terms of both pollution potential and product contamination.

### 4.5 Waste quantity measurement systems

- 4.5.1 All incoming waste loads and outgoing product loads are checked over a surface mounted 50 tonne capacity weighbridge approved for such use by Trading Standards.
- 4.5.2 The weighbridge is permanently manned during normal working hours and is used to weigh all sales from the complex including products from the MRF.
- 4.5.3 It is located as indicated on Figure JPE/MRF/03.

### 4.6 Storage of specified waste

4.6.1 Within the reception building, there are separate storage locations for C&I waste streams and C&D wastes. This allows those wastes which do not require significant levels of sorting to be diverted directly to the aggregate washing section. The appropriate storage areas are clearly marked with their respective

contents and the location of the waste reception building is indicated on Figure JPE/MRF/03.

# 4.7 Specified waste treatment process - plant, equipment and procedures

#### Mechanical and Hand Sorting (MRF)

- 4.7.1 C&I waste streams are subject to sorting into waste types within an elevated picking station where bulk recyclates are recovered by hand and transfered to separate storage containers. To assist this process, fines are removed through a rough screening process prior to sorting by hand. A variety of air separation techniques are also employed. Blown or vacuumed materials are contained within sealed collection enclosures. Airflows are re-circulated through dust arresting systems.
- 4.7.2 Recyclates such as card and plastics are baled and stored within the buildings prior to despatch for further processing. Recovered metals are similarly stored in bulk containers for sale and removal from site.

## Crushing, washing and grading operations (washing plant)

- 4.7.3 Hard recyclates and source segregated streams from C&D arisings are crushed as appropriate and fed to the adjacent washing facility where fines and clays are removed through a scrubbing process and the products separated in differing size fractions by screening.
- 4.7.2 Equipment used in the processes is listed in Appendix 3. This equipment is available on site on a permanent basis.
- 4.7.7 Fines and clays from the washing process are recovered, together with clean water for re-use in the washing plant, using a filter press system. This produces a low moisture filter cake which is removed to landfill for disposal.

#### Throughput

- 4.7.8 The site has a combined throughput capacity of around 250,000 tonnes per annum.
- 4.7.9 Details of each waste stream proposed to be handled within the site are set out in Section 1 above.

# Maintenance and Operation of Plant and Equipment

- 4.7.10 A schedule of plant required on a regular basis for effective site operation is contained in Appendix 2.
- 4.7.11 Additional plant may be required to meet a specific, short-term need or during periods of peak activity.
- 4.7.12 The site operates a strict maintenance regime and all equipment is of sufficient capacity to allow down time for routine maintenance and servicing as recommended by the manufacturer.
- 4.7.13 Fluid and fuel levels are checked on all plant daily together with guard security and general condition. Any defects are reported to and logged by the Site Manager who will action the reports as necessary.
- 4.7.14 No plant may be operated unless full instructions and training have been given by a person competent to do so. No plant or equipment may be worked on for maintenance purposes unless it has been isolated to prevent an accidental start.
- 4.7.15 All newly arrived or hired in equipment is subject to particular scrutiny to ensure it meets the standards required by both the company and current legislation.
- 4.7.16 All breakdowns or incidents involving plant or equipment are entered in the site diary.

# 5 Amenity Management and Monitoring

# 5.1 Control, monitoring and reporting of dusts, fibres and particulates

- 5.1.1 The complex has the benefit of being fully surfaced and waste storage and processing takes place within purpose built buildings.
- 5.1.2 In keeping with industry best practice, speed limits are strictly enforced for all HGV vehicles.
- 5.1.2 Routeways are regularly dampened during excessively dry periods. This is achieved using a high-pressure hose system fitted with mist spray attachments.
- 5.1.3 Commencement of dust suppression measures is decided by the Site Manager based on the prevailing conditions and visual assessment of the potential for dust emissions to atmosphere.
- 5.1.4 Bulk loose loads are required to sheet vehicles prior to departure from site.
- 5.1.5 Crushing and screening equipment is fitted with dust suppression equipment as required and transfer heights are kept to a minimum. All process plant is located within buildings as is waste feed and products.
- 5.1.6 The site entrance is inspected daily for debris and dust that may be carried onto the public highway. Inspections are recorded in the site diary as are any problems requiring special attention such as hosing or mechanical sweeping.

#### 5.2 Control of odours

5.2.1 The nature of the wastes received are such that odours from the site are minimal.

5.2.2 Should any problems be noted, the source would be identified and removed to a suitable landfill site immediately. Records of such occurrences and action taken are recorded in the site diary.

# 5.3 Control and monitoring of noise

- 5.3.1 All equipment used on site is attenuated to reduce noise emissions which are generally consistent with other activities within the general area. In particular, all equipment is properly silenced and maintained to manufacturer's recommendations to minimise noise emissions.
- 5.3.2 Additional noise attenuation is provided by housing all process operations within a building.

### 5.4 Control of pest infestations

- 5.4.1 Regular checks are made for evidence of vermin and rodents and remedial action taken when required. Reports of any incidents and the action taken is recorded in the site diary.
- 5.4.2 The site is also subject to an independent pest control contract who, in addition to providing regular monitoring, would be notified by site staff in the event of evidence being found between routine visits

#### 5.5 Control of litter

- 5.5.1 Daily checks are made within and around the site for litter which may escape the sorting, collection and baling processes. Any incidents requiring particular attention are entered in the site diary.
- 5.5.2 Generally, such materials are sorted into the containers provided for this purpose and baled immediately to prevent escape.

### 6 Site Records

# 6.1 Security and availability of records

- 6.1.1 All site records including details of incoming wastes and outgoing products are kept in the weighbridge office.
- 6.1.2 These records are available during normal hours of business.

### 6.2 Records of waste movements

- 6.2.1 Waste movement details are maintained in the weighbridge office together with details of product sales and stock levels of unprocessed and processed materials.
- 6.2.2 Records are also maintained of any rejected loads and disposals of minor quantities of non-conforming wastes.

## 6.3 Site diary

- 6.3.1 The site diary is kept at the weighbridge office as with other records.
- 6.3.2 This is used to maintain a daily record of activities and occurrences within the site and includes information on such matters as:
  - Rainfall (noting occurrence) and ambient conditions.
  - Incidents involving fires, spillage or accidents (including nature, location within the site and action taken)
  - Rejection and disposal of non-permitted wastes
  - Condition of security gates and fencing (noting nature of any damage, apparent cause and remedial action taken)
  - Condition and cleaning of drains
  - Incidents of litter, dust, mud or vermin are noted together with action taken
  - Details of equipment hired in and duration of operation

- 6.4 Periodic reporting of environmental performance
- 6.4.1 Records are maintained in the site diary of any complaints from surrounding properties in respect of the operations.

# 7 Health and Safety

# 7.1 Policy Statement

7.1.1 The company operates a strict health and safety policy (Appendix 1), and all employees are required to comply with it. Copies are issued to all new employees as part of their induction process, and it is available for reference in the weighbridge office.

#### 7.2 Personnel

- 7.2.1 All contractors working on the site must comply with the company rules and provide copies of relevant certificates of competence and third party and employers liability insurance.
- 7.2.2 All staff are issued with and required to wear high visibility clothing, hard hats and safety footwear.
- 7.2.3 First aid facilities are provided at the weighbridge office, and a certificated first aider is always available within the complex.
- 7.2.4 Working during hours of darkness is limited to well lit areas.
- 7.2.5 Washroom and messroom facilities are provided within the complex as indicated on Figure JPE/MRF/03.

# 7.3 Equipment

7.3.1 All equipment and procedures used on site must comply with the relevant health and safety legislation and in particular HASWA 1974, PUWER 1998, Noise at Work Regulations 1989, COSHH, RIDDOR 1995 and PPEWR 1992.




