WHEREAS on 31st March 1993 Walsall Metropolitan Borough Council granted a disposal licence relating to a Waste Transfer and Public Waste Disposal Facility on land at Fryers Road, Leamore, Walsall subject to the conditions set out therein.

AND WHEREAS you applied to the Waste Regulation Authority (the 'WRA') to modify the said conditions.

NOTICE IS HEREBY GIVEN that Walsall Metropolitan Borough Council modifies the said conditions as follows:-

- 10 (a) Asbestos cement products shall only be deposited and stored at the facility in a lockable container as detailed in the working plan, which is labelled to show it's contents, and is located as detailed in the working plan. This container shall be kept locked at all times other than when waste is being deposited in it or when being inspected by anyone authorised to do so.
 - (b) Asbestos in any morphological or mineral form other than asbestos cement products shall not be deposited or stored at the facility under any circumstances.
 - (c) The deposit of asbestos cement products into the container detailed in condition 10(a) shall be supervised by a member of staff at the facility so as to minimise a risk of pollution of the environment.
 - (d) No waste other than asbestos cement products shall be stored within this container and only i container shall be used for the deposit and storage of such waste at anyone time as detailed in the working plan.
 - (e) Any asbestos cement products which are deposited at the facility and are liable to give rise to pollution of the environment and/or harm to human health shall be double bagged in suitable disposal bags labelled 'asbestos' as detailed in the working plan and deposited forthwith into the lockable container detailed in condition 10(a).

Appeals

If a licence holder is aggrieved by the decision of the Authority in modifying conditions specified in a waste management licence he may appeal to the Secretary of State in accordance with Section 43 of the Environmental Protection Act 1990.

Notice of an Appeal must be given within 6 months of the date of effect of this modification. The Secretary of State has power to allow a longer period for the giving of notice of an appeal but he will not normally be prepared to exercise this power unless there are special circumstances which excuse the delay in giving notice of an appeal.
